## **Fumigation Checklist**

For Safe and Effective Fumigation, the following steps will be necessary prior to fumigation:

reinstate gas service.  ☐ Electricity must be available, as it will be required to run fans during the fumigation.	☐ Remove all fences and plants attached to structure, cut back plants, bushes, trees, and ivy at least one-to-two feet from foundation of structure to avoid damage to plants.
☐ Remove all mattresses and pillows with water- proof covers, such as "Can't Wet" mattresses for sickrooms, or remove the covers. Remove	☐ Pull back all decorative bark and gravel at least one-to-two feet from foundation.

All people must leave and living things must be removed from your home, such as pets, including fish aquarium, and growing plants	Thoroughly wet the soil the day before fumigation at least one foot outward from foundation to help protect plants and provide a better seal keeping fumigant from escaping.
Shut off automatic switch controls for appliances and lighting systems that will be included in the space to be fumigated.	☐ Lower all awnings attached to the structure. ☐ Cars left inside garage must have all windows and trunk opened.
☐ Unlock and open all drawers and interior doors, including garage, utility and storerooms, closets, cabinets, cupboards, chests, safes, etc., to facilitate rapid circulation and aeration.	☐ The law requires all buildings be locked during a fumigation. Please make key arrangements with Nor-Cal Pest Control prior to fumigation date.
At least one window per room must be opened.	☐ Turn off all air conditioning units.
☐ Extinguish all sources of heat (hot water heaters, ranges, wall heaters, etc.), fireplaces or wood stoves should not be used the day prior to fumigation.	Are you aware of any conduits, pipes, common drains, air ducts, central vacuum systems, or any other construction elements that would allow the passage of a fumigant from the structure
☐ Unplug all heating elements (heaters, pianos, organs, etc.).	to be fumigated to any other adjacent or adjoining structures?

## **Notice**

- We suggest you notify nearby neighbors of the date of fumigation and to keep pets away during the fumigation. Close off any open access to the subarea to prevent pets from entering.
- ◆ The roof structure of the building must be walked on and some damage may occur. In the case of old, brittle wood shingles or tile, there is always the possibility of some breakage. Plants, including vines and trellises, that are close to the building to allow for proper sandbagging of the tarps may be damaged. Where masking tape is used, some painted surfaces, although they appear in good condition, will chip or peel off the undercoating if it was not properly prepared. Due to age and condition of chimneys and roof vents, avoiding damage may not be possible.
- ◆ In case of strong winds or rain, the fumigation may have to be postponed to a later date.
- During the fumigation and aeration procedure, Nor-Cal Pest Control does not provide a guard for security of your property and will not be held responsible for vandalism, theft, or breaking and entering.
- ◆ The washing of dishes, pots, pans, silverware, etc., will not be necessary, as the fumigant does not leave a residue.
- Upon completion of fumigation, Nor-Cal Pest Control will aerate the building thoroughly and check
  it with gas-detecting equipment until structure is safe for re-occupancy. There will be a notice on the
  front door indicating time and date for safe re-entry. (Please keep this notice to show PG&E)
- ♦ I have read this notice and preparation check list and understand my responsibility is to have all prep work completed before the fumigation crew arrives. If items have to be completed by Nor-Cal Pest Control, an additional charge will be added. In case of cancellations or postponement by owner, there will be a \$250<sup>90</sup> charge unless seventy-two hours notice is received by Nor-Cal Pest Control.
